5. Pre-bid meeting shall be held at **Tarakeshwor Rural Municipality, Dangsing, Nuwakot** at **IPM on 2026/10/01**
6. Sealed bids must be submitted to the office **Tarakeshwor Rural Municipality, Dangsing, Nuwakot** by hand/courier on or before **12 PM** on **2026/10/13**. Bids received after this deadline will be rejected.
7. The bids will be opened in the presence of Bidders' representatives who choose to attend at **IPM on 2026/10/13** at the office of **Tarakeshwor Rural Municipality, Dangsing, Nuwakot**. Bids must be valid for a period of **30 days** from the bid submission deadline and must be accompanied by a bid security amounting to a minimum of the amount as mentioned below, which shall be valid for 30 days beyond the validity period of the bid (i.e. **2027/01/11**)
